RE: Statement made during Wheatland County's Special Council Meeting on March 12, 2024

During Wheatland County's Special Council Meeting on March 12, 2024, Councillor Ikert made a statement regarding the Town of Strathmore's financial position and ability to support the Wheatland Housing Management Body's (WHMB) proposed development of a 120-unit lodge. The statement was as follows:

"The board believes that they can requisition us \$1.6 million? Does the board understand that that number will cripple the Town of Strathmore? I mean it does not do us any good, but it will cripple the Town of Strathmore."

This statement is fallacious and damaging to both the Town of Strathmore's reputation and the potential development of the 120-unit Wheatland Lodge. As you are aware, both Wheatland County and the Town of Strathmore have passed resolutions supporting WHMB's proposed development of a 120-unit lodge—provided certain parameters are met. In the interest of collaboration and partnership between our communities, the Town of Strathmore requests that the above statement be retracted, and a public apology be made to the Town.




