BYLAW NO. 22-20 TOWN OF STRATHMORE IN THE PROVINCE OF ALBERTA

BEING A BYLAW OF THE TOWN OF STRATHMORE IN THE PROVINCE OF ALBERTA TO AMEND THE RESPONSIBLE ANIMAL CONTROL BYLAW NO. 18-18.

WHEREAS Section 7 and 8 of the Municipal Government Act, R.S.A. 2000, Chapter M-26, as amended thereto, authorizes the Town of Strathmore Council to pass bylaws to license and regulate wild and domestic animals and activities in relation to them;

AND WHEREAS Council deems it advisable to adopt such a bylaw;

NOW THEREFORE BE IT RESOLVED THAT the Municipal Council of the Town of Strathmore, in the Province of Alberta duly assembled **HEREBY ENACTS AS FOLLOWS**:

1. SHORT TITLE

1.1. This Bylaw may be cited as "Responsible Animal Control Amending Bylaw No. 22-20."

2. AMENDMENTS

- 2.1. That section 2.1 (nn)(i) be amended to state, "Any animal which has, without provocation, chased in an aggressive manner, attacked, or bitten an Animal or Person;"
- 2.2. That Schedule "A" of this bylaw be added to the Responsible Animal Control Bylaw No. 18-18 as Schedule "C".
- 2.3. That the Responsible Animal Control Bylaw No. 18-18 be amended as follows:
 - "11.1. Any person who contravenes any provision of this Bylaw is guilty of an offence and is liable to a penalty not less than the minimum penalty set out in Schedule "C" of this Bylaw.
 - 11.2. Notwithstanding section 11.1. of this Bylaw, any Person who commits a second or subsequent offence under this Bylaw within one (1) year of committing a first offence under this Bylaw, will be liable to a penalty set out in Schedule "C" of this Bylaw."
- 2.3. That Schedule "A" of the Responsible Animal Control Bylaw No. 18-18 be amended as follows:
 - "3.3. A person who is guilty of an offence under this bylaw is liable to a fine as set out in Schedule "C" of this Bylaw."

3.1. This Bylaw comes into full force and effect upon third and final reading and being signed.
