

BYLAW NO. 21-03 TOWN OF STRATHMORE IN THE PROVINCE OF ALBERTA

# BEING A BYLAW OF THE TOWN OF STRATHMORE IN THE PROVINCE OF ALBERTA TO AMEND THE WATER UTILITY BYLAW NO. 18-06

WHEREAS the Municipal Government Act, being Chapter M-26, of the Revised Statutes of Alberta 2000 and amendments thereto provides authority for the Town to regulate such matters;

**NOW THEREFORE BE IT RESOLVED THAT** the Municipal Council of the Town of Strathmore, in the Province of Alberta duly assembled **HEREBY ENACTS AS FOLLOWS**:

1.3 That the following sections be amended to reference Bylaw 13-21 Fees Bylaw and amendments thereto:

#### Section 8.1

A Person requesting Town Water Service must submit an application for same to the Town together with the fee, as listed in Bylaw 13-21 Fees Bylaw, and any applicable security required by Council;



#### Section 8.2 (a)

8.2 (a) all the applicable fees as listed in Bylaw No. 13-21 Fees Bylaw required by Council have been paid;

#### **Section 15.2 (a)**

15.2 (a) a complete application form and the fee, as listed in Bylaw No. 13-21 Fees Bylaw prescribed by Council; and

#### Section 19.1

19.1 A Person must submit an application and pay the applicable fees, as listed in Bylaw No. 13-21 Fees Bylaw.
